Short Term Eligibility

- Personal illness, injury or traumatic lived experience ((within 6 months)
- Families facing bereavement (within 6 months)
- Recent redundancy (within 6 months)
- Injury or Illness to parent, guardians, or carer (Within 6 months)
- Parent in Full time Education.
- Sibling illness, injury, or complications.
